- **In Holland, Murder is a Normal thing to do = Hidden Community-act...**

Victims are often forced by NL-judges to restart Lawcases in Appeal... or when new evidence shows up, while the Criminals is kept Low-profile and nurtured with Easy-going courttrials. Victims must prove the REAL LegalFramework, not the criminals.

30 Years the State of Law the Netherlands was more fair to Victims = Criminals were punished more.
